# 1. Aspiration Statement

- The New Take on the Lake has transformed Burke Lakefront Airport into a vibrant waterfront district accessible to all. This repurposing of public land has become a global model for inclusive community-led planning that resulted in the creation of public access and bikeways, market rate and affordable housing, corporate offices, water-based recreation and a year-round event center all built in an environmentally sustainable way that heals the lakefront. It is now a place that unites people of all social, economic, racial, backgrounds through opportunities to play, live, work and discover.
- The 450 acres of land that once supported 35,000 annual flights is now a magnet for all people of CLE attracting 5 million visits per year from all over the region and the world. It has become a catalyst for lakefront access and development throughout the region.

  - Best Use: What is the best use to activate this property in the most publicly accessible and economically stimulating way?
  - Funding: How do we pay for it?
  - Stewardship: Who will own, maintain and manage the programming of the new space?

 Burke Lakefront Airport, a general aviation and reliever airport covering 450 acres. In addition to airport operations, tenants include city of CLE agencies, non-aviation businesses, the International Women's Air & Space Museum, site of annual Cleveland Air Show

 Public, private, social stakeholders arrive at longterm action plan to repurpose Burke and adjacent property with opportunities sustainable live, work, play uses and greater access for Greater CLE's entire population

### **Lived Experience**

 We believe this action plan will improve the data point and the lived experience of Greater Clevelanders because... New Take on the Lake will increase employment opportunities from new construction through on-site employment, diverse sustainable housing options, increase access to area through redesigned roadways, ped & bike access, new transit routes, active and passive recreation, habitat restoration for flora, fauna, birds, insects, education opportunities through managed programs and associated activity areas including gathering and performance spaces
