1. Aspiration Statement

We successfully established a state-wide minimum wage of \$15 per hour indexed to inflation



2. Action Plan

- Identify other Clevelanders who support an increased minimum wage.
- Partner with established organizations who are working towards an increase, share our collected data and involve supporters.



3. The Change We Want to See in the Data

Today's Data

- 37% of Ohio's population is currently making less than 15.00 per hour.
- Wage gaps exist based on gender and race. Women and people of color make significantly less than white men, even in lower wage jobs
- Inflation is currently 2.5% and Ohio's minimum wage of 8.70 has less buying power every year.

2030 after Action Plan

- Inject 8.7 billion dollars into the economy by raising the wages of 2 million Ohioans
- Erase pay gaps by raising the wages of all low wage earners
- Tie the minimum wage to inflation, boosting wages to 19.19 by 2030

4. The Change We Want to See in the Lived Experience

Today's Lived Experience

- Today's low minimum wage has been tied to low birthweights, teen births and premature deaths
- Low wages lead to poor diet, an increase in smoking, and increased teen alcohol consumption
- From a health aspect there is little difference between the stresses of poverty and exposure to harmful chemicals

2030 after Action Plan

 Improvement in the factors listed under today's lived experience

<u>and</u>

- Reduced reports of child neglect and abuse
- Increased access to prescription drugs
- Better overall physical and mental health and increased life expectancy
- Neighborhood resurgence



5. How Our Action Plan Leads to the Change

Lived Experience

- This will have the exact opposite effect of a tax cut for the top one percent. This is an 8.7 billion-dollar investment in the "real" economy. The purchased goods and services from increased wages will have a direct, positive impact on businesses, both locally and nationally.
- Increased wages means increased tax revenue. Tax revenue, when in the right hands, funds improved infrastructure, protected and maintained natural resources and allows for investment in technology.

Economic Growth
